New Wapack Trail protection opportunity in New Ipswich

Opportunity to protect 1 mile of the Wapack Trail while conserving 485 acres around the trail

In our Spring / Summer newsletter we reported that a tract of about 485 acres is for sale in the area of Binney Hill Road in New Ipswich. Known as the Binney Hill property, it includes about 1 mile of the Wapack Trail. We saw this as an opportunity to obtain a trail easement to protect one of the last large sections of the Wapack Trail that is on private land. Also, a conservation easement on this property would connect conserved land around Mt. Watatic in Massachusetts to the south with the Binney Pond Natural Area and the Wapack Wilderness conservation easement to the north. This would result in nearly all of the land being conserved and the trail protected from Mt. Watatic to Barrett Mountain —the southern end of the Wapack Range.

We now have great news that the Northeast Wilderness Trust (NWT), a conservation land trust who's purpose is to protect forever-wild landscapes for nature and people, is looking at purchasing the property. We have been in conversation with Daryl Burtnett, the Executive Director of NWT, to see how our organizations can work together to protect the trail and this property. The NWT has approached the seller to get a purchase option agreement. In order to move that effort forward they are looking for financial pledges of support. The advertised price for the 484.7 acres is \$743,000. So this will require a significant fund raising effort. The Friends of the Wapack are ready to actively participate in and support a fund

raising effort to protect the trail and this property. The Northeast Wilderness Trust presently holds the conservation easement on the Wapack Wilderness property, which includes 1,400 acres in Rindge and New Ipswich, and includes about 1.3 miles of the Wapack Trail on Pratt Mountain and Stoney Top. The Friends partnered with NWT in that successful effort, and we are looking forward to working with them again to protect the trail and this wild landscape along the Wapack Range. Please consider supporting this effort to protect both the trail and the land on one of the last large unprotected properties along the Wapack Range!

It's certainly been an eventful year for the Friends of the Wapack! The year started with the publication of our all new, full color, "Guide to the Wapack Trail". The guide has been very well received, with over 323 sold. They are available on line at Wapack.org, at the Toadstool Bookshops, and at EMS.

We've had three successful, well attended trail work days. On our first work day on May 16th we installed several much needed rock waterbars on the Wapack Trail at Windblown XC Ski Area to prevent erosion on this new section of the trail. On NH Trails Day, July 18th, we built several bog bridges in a seasonally wet area on the Beebe Trail. And on September 26, we build a new foot bridge across a stream on the Raymond Trail. The new stronger and wider bridge replaces a deteriorating and narrow log bridge. Thanks to all who helped! See photos below from these work days.

In our Spring newsletter we listed two new challenges. One of those challenges is the opportunity to protect about 1 mile of the Wapack Trail, and 485 acres in the area of Binney Pond in New Ipswich. Winter use of the Wapack Trail through Windblown Cross-Country Ski Area

- 1. With snow on the ground everyone using the Wapack Trail through Windblown property needs to pay for a trail ticket.
- 2. Everyone must use skis or snowshoes, no hiking.
- 3. In winter with a trail ticket you can use the Windblown parking lot during the day, not overnight.
- 4. Dogs are not permitted.
- 5. Check the Windblown website to see if they are open or stop into the ski shop between 9 and 5. If not open no trail fee.
- 6. Snowshoers need to stay out of the ski tracks.
- 7. People coming from south to north and not leaving a car in the lot can pay on their way out. Thank you!



NED Pipeline Update

In keeping with our organization's charter to protect and maintain the trails, the Friends of the Wapack have many concerns regarding the possible impact to the Wapack Trail by the proposed NED gas pipeline.

The gas pipeline would intersect the Wapack Trail at two locations in New Ipswich. The first is at the Windblown Cross Country Ski Area, where the pipeline would impact 800 feet of the Wapack Trail. Double that distance for ongoing visual impacts resulting from the additional clearing along the transmission line. The second location is to the east of Turnpike Road where the pipeline will directly impact 112 feet of the trail. The NED pipeline will also impact 350 feet of the Kidder Mountain Trail.

Pipeline construction will result in trail surface changes which may include new erosion issues and wet areas, exposed rocks and boulders, debris left from the clearing and pipeline construction, as well as the visual impact of a much wider power line clearing and staging area clearings.

Another major concern are the visual and sound impacts of the 41,000 hp compressor station which is planned to be built in New Ipswich. The compressor station may be visible and will likely be heard from Kidder Mountain, which is only two miles from the proposed compressor station. It may also be seen and heard from the Wapack Trail along some locations of the Temple Mountain ridge.

We oppose any impacts from this project that would restrict access to or degrade the trail. We have met with Kinder Morgan officials, submitted comments within the Federal Energy Regulatory Commission process, and have provided a statement to the Southwest Regional Planning Commission to make our position and concerns known. - FoW Board of Directors
